#### **End User:**

- 1. When Possible, please take digital photos of the problem part or area. Email pictures to <a href="mailto:sales@durabodv.com">sales@durabodv.com</a>
- 2. Call Durabody Industries Toll Free at 1-800-661-3775 to discuss the nature of the problem with a Durabody representative.
- 3. Prior to the warranty repair or replacement of parts, the warranty claim must be approved by the Durabody Warranty Department. If work is to be carried out by an alternative facility a written repair estimate must be submitted and an approved course of action agreed to prior to repairs or part replacement being performed.
- 4. Durabody will authorize a course of action. This could include.
- A) Durabody will ship warranty part(s) to end user for installation/repair at agreed upon job time and hourly rate
- B) Refer Customer to authorized Durabody Service Center for the repair
- C) Refer customer to Durabody or Gin-Cor manufacturing facility for repair.
- 5. Durabody will invoice and ship replacement parts to the end user based on the agreed repair/installation charges pending "warranty" evaluation
- 6. Defective and/or replaced parts must be shipped to Durabody Industries for warranty evaluation. No work orders will be paid without the return of defective product. Advise dealership or repair center to ship any defective or replaced parts to Durabody. Product must be received within 30 days of repair/replacement being performed, failure to return parts will forfeit any claim pending.

If defective parts are approved under warranty Durabody will reimburse the customer for invoicing and freight charges.

#### This Warranty Shall not Apply To:

- 1. Any unit which has been altered in any way so as, in the judgement of the Company to affect adversely its operation or reliability.
- 2. Any unit which has been subject to misuse, negligence, or accident. Where the unit is found to have been misused from the originally intended or designed purpose and/or maintenance has been neglected, Durabody reserves the right to decline a claim for warranty based on conclusions it finds whether or not repairs are initiated.
- 3. Any unit which has been operated at a speed exceeding the recommended speed or loaded beyond the rated load capacity.
- 4. Normal maintenance service or adjustments.
- 5. Tires, tubes, hydraulic fluids and other products supplied by other manufactures, warranty on which is limited to that extended by the other manufacturers.

- 6. Reimbursement for payments arising from incidental or consequential loss of income caused by "down-time", alternate transportation costs, lodging costs, costs of replacement vehicles, fuel, insurance and mileage expense, should the unit be out of service for warranty repair or any other reason.
- 7. Costs of additional removal and replacement of signage and interior components in order to facilitate vehicle repairs.
- 8. Shipping costs incurred to return vendor items or the entire unit for warranty claims and repair are the responsibility of the purchaser. Should a component vendor later elect to provide adjustments for these they will be credited accordingly
- 9. Exposure to corrosive, hazardous, eroding or decaying products/elements or unsafe cargo which may deteriorate the integrity of any part of the unit.

The Company makes no warranties, express or implied, or merchantability and fitness for a particular purpose otherwise. If warranty is performed by an out of town repair facility, liability will be limited to flat rate replacement charges.
