

WARRANTY CONDITIONS OF SALE

JC Trailers Design & Fabrication Inc. WARRANTY AGREEMENT

MAIN FRAME

JC Trailers Design & Manufacturing Inc. (further known as "JC Trailers") shall bear all or a portion, as listed below, of replacing or repairing the main frame (or parts manufactured by JC Trailers) provided that the equipment warranted hereunder is operated by the purchaser in accordance with the practice approved by JC Trailers, with loads not exceeding the manufacturer's rated capacities and used on a well maintained public roads with limited off road usage.

This refers to JC Trailers:

Standard platform trailers, super "B" trains or step decks, if manufactured to our standards and specifications up to 5 years – one year at 100%, two years at 80%, three years at 60%, four years at 40%, and five years at 20%.

Floats, hydraulic and mechanical detachables and tag-a-long trailers, hydraulic beavertail, hydraulic tilt and extendable trailers – one year at 100% warranty on frame and parts manufactured by JC Trailers.

Specialized trailers made to customers design including oilfield trailers, perimeter frame extendable trailers, specialized heavy haul transporters, pole trailers, etc. – three months at 100% warranty on frame and parts manufactured by JC Trailers.

JC Trailers makes no warranty as to parts or accessories manufactured by others. This includes the following:

1) Axles, suspension, landing gear, wheels, rims, hubs, hydraulic valves, and other components.

2) Air lines, springs, air bags, leveling valves, oil seals, air brake control valves, brake drums, shock absorbers, electrical parts, hydraulic cylinders, hoses, and connections.

3) Tires, tubes, engines - warranty claims must be made directly to their respective dealers.

4) There is no warranty on paint, decking or outriggers.

JC Trailers may assign to the customer any warranties in favour of JC Trailers with respect to any such parts or accessories which may legally be assigned by JC Trailers.

5) Any invoices covering warranty parts and/or labour that we consider excessive will be paid on the basis of our cost of such parts and or labour as if the work had been done at our factory. All invoices submitted, requesting warranty, must show the number of hours of labour. JC Trailers will pay labour on all authorized repairs at a pre-approved labour rate.

6) No warranty on parts will be paid for until the faulty parts have been returned prepaid, for our inspection.

7) Any goods which after delivery hereunder have been repaired or altered by anyone other than Manufacturer or one of its authorized service representatives voids all warranty.

8) Manufacturer and Customer agree that the Manufacturer shall have no liability for any cargo loss, loss of use of trailer or any other incidental or consequential damages arising which are alleged to have been caused by the trailer.

JC Trailers Design and Manufacturing Inc. makes the foregoing non-assignable warranty solely to the first purchaser.
