



**GIN-COR INDUSTRIES DUMP BODY WARRANTY POLICY**

Gin-Cor Industries Inc., hereinafter called "The Company", warrants each new dump body unit installed to be free from defects in material and workmanship under normal use and service, its obligation under this warranty being to repairing or replacing any part or parts thereof, including all accessories as manufactured by the Company, **within 1 year after delivery to the original purchaser.** Such defective part or parts will be repaired or replaced free of charge and without charge for installation to the original purchaser, provided work is performed in our shop. If work is to be carried out by an alternate facility a written repair estimate must be submitted to us before a purchase order can be issued to carry out the work needed. **Replacement parts will only be warranted for the remaining term of this 1 year warranty.**

**ALL WARRANTY CLAIMS MUST BE APPROVED BY AN AUTHORIZED COMPANY REPRESENTATIVE PRIOR TO REPAIR AND/OR PURCHASE OF PARTS.** This warranty shall not apply to:

- 1) Any unit which shall have been altered in any way so as, in the judgement of the Company to affect adversely its operation or reliability.
- 2) Any unit which has been subject to misuse, negligence, or accident.
- 3) Any unit which shall have been operated at a speed exceeding the recommended speed or loaded beyond the rated load capacity.
- 4) Normal maintenance service or adjustments.
- 5) This warranty shall not apply to any damage resulting from the upsetting of dump trucks, dump semi-trailers or dump semi-trailer trains, and the Company shall not be responsible for or liable for any damage as a result thereof.
- 6) Tires, tubes, hydraulic fluids and other products supplied by other manufacturers, warranty on which is limited to that extended by the other manufacturers.

This warranty is limited to replacement or repair at the Company's factory in Mattawa, Ontario. Any parts authorized for return by the Company **will be returned freight prepaid by the end user.** The Company shall not be responsible for the loss of products, time, or for consequential damages of any nature or kind. The Company makes no warranties, express or implied, or merchantability and fitness for a particular purpose or otherwise. If warranty is performed by an out of town repair shop, liability will be limited to flat rate replacement charges.

Note: If said unit is not installed by Gin-Cor Industries the installer of the above unit becomes responsible in assisting with all warranty claims. Any defects caused by workmanship will be deemed to be the installer's responsibility.
